
WHEREAS, around 1,000 under privileged families had been relocated in Colmenar, General Trias, Cavite under the Pabahay 2000 of the Public Estates Authority;

WHEREAS, the source of their livelihood is derived either from carpentry, masonry, vending or factory workers;

WHEREAS, it is the commitment of the present administration to improve the quality of life of the people, specially the less fortunate, through people empowerment and sustainable economic development;

WHEREAS, cooperative have been chosen as one of the vehicles for the attainment of both people empowerment and sustainable economic development;

WHEREAS, the present residents in the reclamation area who are among the least privileged will be relocated to Colmenar, General Trias, Cavite where they will be given opportunities for socio-economic advancement;

WHEREAS, the relocated residents from the reclamation area will eventually be organized into cooperative to enable them to collectively undertake their livelihood activities and socio-cultural development endeavors;

WHEREAS, the government sector thru the CDA, PEA and the local government of General Trias, non-government organizations like CFPI and other religious and Civic organizations have volunteered to assist the relocatees in attaining the above objectives.

NOW THEREFORE, on motion of SB Member Ruben M. Parani duly seconded by SB Member Ariel M. Mugol, this Body

RESOLVED, as it is hereby resolved, to authorize the Local Chief Executive to sign for and in behalf of the Municipal Government of General Trias the Memorandum of Agreement between the Cooperative Development Authority, Public Estates Authority and the Cooperative Foundation of the Philippines Inc. in handling the cooperatives.

WHEREAS, the same has been released to Gentry through the intercession of Representative Renato P. Dragon;


