On motion of SB Member Felix A. Grepo duly seconded by SB Members Luis A. Ferrer IV and Rodolfo P. Satsatin, this Body

RESOLVED, to enact an ordinance imposing fees on certifications/clearances issued by the Mayor, Mun. Planning & Development Coordinator and Health Office for the proposed and approved developmental projects, to be designated as Municipal Ordinance No. 1-97, to be read as follows:

MUNICIPAL ORDINANCE NO. 1-97

AN ORDINANCE IMPOSING FEES ON CERTIFICATIONS/CLEARANCES ISSUED BY THE MAYOR, MUNICIPAL PLANNING & DEVELOPMENT COORDINATOR AND HEALTH OFFICE FOR THE PROPOSED AND APPROVED DEVELOPMENTAL PROJECTS.

Be it ordained by the Sangguniang Bayan of General Trias, Cavite, that:

Section 1. - SCHEDULE OF FEES

Fees on certifications/clearances issued by the Mayor, Municipal Planning & Development **Officer and Health Officer** are hereby imposed on persons or entities requesting for documents prescribed hereunder.

A. TYPE OF DOCUMENT ISSUED BY THE MAYOR

- a). Mayor's clearance to conduct well drilling or extract underground water resources needed by National Water Resources Board for 3" casing and above - ₱500.00/well  
2" casing and above - ₱200.00/well

- b). Mayor's clearance for conversion order & posting (DAR requirement) ₱100.00/ha.
- c). Mayor's clearance for project to secure DENR approval
  - 1. Warehouse & stockyard ₱100.00
  - 2. Fabrication & manufacturing ₱200.00
  - 3. Subdivision & recreational, parks and playground ₱ 75.00
  - 4. commercial establishment ₱ 50.00
- d). Other certification ₱ 50.00

B. TYPE OF DOCUMENT ISSUED BY THE MUNICIPAL PLANNING & DEVELOPMENT OFFICER

- a). Certification of additional approved subdivision plan and permit (in excess of 5 shts.) ₱ 50.00/sheet
- b). Certification of other related document ₱ 25.00

C. TYPE OF DOCUMENT ISSUED BY THE MUNICIPAL HEALTH OFFICER

- a. Certification as to conformity to Philippine Sanitation Code
  - 1. water/sewerage treatment plan ₱ 500.00/project
  - 2. centralized water tank ₱1,000.00/project
  - 3. septic tank ₱ 10.00/tank
  - 4. drainage outfall (on rivers, creeks) ₱ 50.00/outfall
  - 5. subdivision- drainage system ₱ 100.00/ha.
  - 6. subdivision- sewerage system ₱ 100.00/ha.
  - 7. subdivision- water system ₱ 100.00/ha.
  - 8. construction of individual well with or without pumps ₱ 50.00/well
  - 9. other certifications ₱ 50.00

SECTION 2 - MODE OF PAYMENT

Imposed fee shall be assessed by the Municipal Planning and Development Officer or his designated staff. Payment shall be made at the Treasurer's Office before issuance of document by the Mayor, Municipal Planning & Development Coordinator and Health Office. Amount of fees paid, date of payment and official receipt shall be reflected on the document.

SECTION 3. - EXEMPTION FROM PAYMENT

- 1. Those requesting clearance from government institutions, non-gov't. organizations, people's organization, cooperatives, senior citizen and students.
- 2. Those requesting for a certified copy of plans or permits filed in the Office of the Municipal Planning & Development Coordinator from government institution or government owned and controlled corporation.

SECTION 4. - EFFECTIVITY

This ordinance shall take <sup>effect</sup> on February 21, 1997.
