ENACTING A MUNICIPAL ORDINANCE GRANTING EXEMPLARY PUBLIC SERVICE AWARD (EPSA) TO ANY ELECTIVE LOCAL OFFICIAL OF THE MUNICIPALITY OF GENERAL TRIAS WHO HAS BEEN ELECTED FOR THREE CONSECUTIVE TERMS IN THE SAME POSITION.

WHEREAS, it is recognized that the meager salaries of the elective local officials are not commensurate to their functions, multifarious services, and various civil duties to the constituents of this municipality, not to mention the financial support continually being sought from them during office hours and off-hours even in the privacy of their respective homes;

WHEREAS, this august Body believes that it is only befitting and proper that the sacrifices of elective local officials be conferred recognition and award as acknowledgement and gratitude to their exemplary services;

NOW THEREFORE, on motion of SB Member Carlos S. Viniegra II, Chairman, Committee on Appropriation, Finance and Budget as seconded by the Sangguniang Bayan Members, be it

RESOLVED, AS IT IS HEREBY RESOLVED to enact a Municipal Ordinance granting Exemplary Public Service Award (EPSA) to any elective local official of the municipality of General Trias who has been elected for three consecutive terms in the same position to read as follows:

MUNICIPAL ORDINANCE NO. 06-03

SECTION 1. TITLE. This ordinance shall be known as "An ordinance Granting the Exemplary Public Service Award (EPSA) to any elective local official of the municipality of General Trias who has been elected for three (3) consecutive terms in the same position.

SECTION 2. COVERAGE. Any elective municipal officials like the Municipal Mayor, the Municipal Vice Mayor and the Sangguniang Bayan Members who have been elected for three (3) consecutive terms shall be entitled to benefits mentioned in Section 4 of this ordinance.

SECTION 3. DEFINITION OF TERMS.

EXEMPLARY - serving as a model or example

CONSECUTIVE - following in uninterrupted order, successive

SECTION 4. GENERAL PROVISION.

- A. The EPSA shall consist of Plaque of Appreciation and cash awards
- B. Upon the effectivity of this ordinance, the incumbent municipal elective officials and those who will be elected in the succeeding local elections shall be eligible to receive the EPSA and other benefits provided they are elected for three (3) consecutive terms in the same position,
- C. For the purpose of computation of EPSA, the following shall apply to the recipient who has been elected for three (3) consecutive terms:

P 1 000 000 (One Million Pesos) for the Municipal Mayor,

P 750 000 (Seven Hundred Fifty Thousand Pesos) for the Municipal Vice Mayor,

P 500 000 (Five Hundred Thousand Pesos) for the Sangguniang Bayan Member.

- D. PROVIDED, that the recipient elective local official has not been declared guilty of any administrative or criminal offense at any time during his term of office. Such an offense shall disqualify the recipient local official of the Exemplary Public Service Award (EPSA).

ENACTING A MUNICIPAL ORDINANCE GRANTING EXEMPLARY PUBLIC SERVICE AWARD (EPSA) TO ANY ELECTIVE LOCAL OFFICIAL OF THE MUNICIPALITY OF GENERAL TRIAS WHO HAS BEEN ELECTED FOR THREE CONSECUTIVE TERMS IN THE SAME POSITION.

SECTION 5. MODE OF PAYMENT. As provided in Section 4 of this ordinance, the cash award shall be given to the EPSA recipient within one year after the last day of his service subject however to availability of funds. In case of death of the EPSA recipient, the cash award will be given to the nearest heir.

SECTION 6. YEARLY APPROPRIATION. The Budget Office shall see to it that annual appropriation for this ordinance be allocated.

SECTION 7. REPEALING CLAUSE. Any ordinance, resolution or administrative issuances or part thereof inconsistent with the provision of this ordinance is hereby repealed, amended or modified accordingly.

SECTION 8. SEPARABILITY CLAUSE. If any section or provision of this ordinance is declared invalid, the remainder of this ordinance shall not be affected by such declaration.

SECTION 9. EFFECTIVITY. This ordinance shall take effect upon its approval.
