ENACTING AN ORDINANCE REQUIRING THE INSTALLATION, OPERATION AND MAINTENANCE OF CLOSED-CIRCUIT TELEVISION (CCTV) ON ALL BANKS, PAWNSHOPS, LENDING AND/OR ANY OTHER FINANCIAL INSTITUTIONS WITHIN THE MUNICIPALITY OF GENERAL TRIAS AND PROVIDING PENALTIES FOR ANY VIOLATIONS THEREOF.

WHEREAS, to curtail the occurrence of crimes against banks, pawnshop, and/or any other financial institution, installation, operation and maintenance of Closed-Circuit Television is necessary to promote maximum protection to life and property;

WHEREAS, Section 447(1) (ii) of the Local Government Code of 1991 provides that, the Sangguniang Bayan as the legislative body of the municipality shall "Maintain peace and order by enacting measure to prevent and suppress lawlessness, disorder, riot, violate, rebellion or sedition and impose penalties for the violation of the said ordinance;

WHEREAS, public hearing was conducted for this purpose;

WHEREFORE, on the motion of SB Member Maurito C. Sison duly seconded by SB member Alfredo L. Pozas, be it

RESOLVED, AS IT IS HEREBY RESOLVED to enact an Ordinance requiring the installation, operation and maintenance of Closed-Circuit Television (CCTV) on all banks, pawnshops, lending and/or any other financial institution within the municipality of General Trias, to be designated as Municipal Ordinance no. 09-01, to wit:

MUNICIPAL ORDINANCE NO. 09-01

AN ORDINANCE REQUIRING THE INSTALLATION, OPERATION AND MAINTENANCE OF CLOSED-CIRCUIT TELEVISION (CCTV) ON ALL BANKS PAWNSHOPS, LENDING AND/OR ANY OTHER FINANCIAL INSTITUTIONS WITHIN THE MUNICIPALITY OF GENERAL TRIAS AND PROVIDING PENALTIES FOR ANY VIOLATIONS THEREOF.

Be it ordained by the Sangguniang Bayan

Section 1. No bank, pawnshop and/or any other financial institution within the Municipality of General Trias shall be issued a permit to operate without the required installation of Closed-Circuit Television (CCTV) within the establishment.

Section 2. Closed-Circuit Television (CCTV) to be installed shall strictly conform to the standards set by the General Trias Municipal Police.

Section 3. The Municipal Business Permit & Licensing Office (BPLO) and General Trias Municipal Police are task to monitor on the establishments regarding the compliance to this Ordinance;




