**AN ORDINANCE NAMING THE NEWLY CONSTRUCTED SCHOOL BUILDING AT KALINGA VILLAGE (LRTA), BARANGAY SANTIAGO AS KALINGA VILLAGE ELEMENTARY SCHOOL.**

**WHEREAS**, the Department of Education (DepEd) Order No. 40, Series of 2014 provides the naming of public schools as one requirement in the establishment of such;

**WHEREAS**, a public elementary school building was built at Kalinga Village (LRTA) in Barangay Santiago;

**WHEREAS**, the Office of the City Engineer conducted on-site inspections of the newly constructed school building at Kalinga Village (LRTA) and ensured that the said building complies with the Department of Education (DepEd) building and other regulatory standards for infrastructure projects;

**WHEREAS**, the members of the Local School Board recommended the naming of the abovementioned newly constructed school as Kalinga Village Elementary School;

**NOW THEREFORE**, on motion of SP Member Vivencio Q. Lozares, Jr. duly seconded by SP Member Clarissel J. Campaña-Moral,

**Be it enacted by the Sangguniang Panlungsod, that:**

**Section 1. TITLE** – This Ordinance shall be known as "THE NAMING OF KALINGA VILLAGE ELEMENTARY SCHOOL ORDINANCE".

**Section 2. DECLARATION OF POLICY** – It is the policy of the City Government of General Trias to promote the general welfare of students through establishment of public schools.

**Section 3. NAMING OF SCHOOL** – The newly constructed school at Kalinga Village (LRTA), Barangay Santiago is hereby named as Kalinga Village Elementary School.

**Section 4. EFFECTIVITY** – This Ordinance shall take effect upon approval.






