DECLARING THE TEMPORARY CLOSURE OF SAN JUAN-TEJERO NIA ROAD FOR THE CONSTRUCTION OF DRAINAGE CANAL.

WHEREAS, the San Juan-Tejero Bypass Road, being one of the busiest and major bypass roads in the City, needs to be maintained to let traffic flow without interference and to reduce traffic congestion in the area;

WHEREAS, in the past years, it has been observed that the abovementioned area becomes flooded during heavy rains and as a consequence increases traffic jams, worsens traffic problems, and poses danger to the public;

WHEREAS, after a rigorous inspection of the area involved and a thorough study of the problem by the concerned agencies, the immediate construction of a drainage canal in the area was recommended to resolve the problem;

WHEREAS, it is understood that poor drainage is a traffic safety risk, a contributor to the permanent damages on the roads, and the main cause of problems related to long term road serviceability, therefore there is an urgency to construct the drainage canal in San Juan-Tejero NIA Road;

WHEREAS, the construction of a drainage canal in San Juan-Tejero NIA Road shall promote safety and welfare of the people in the long term;

WHEREAS, Section 21 of the Local Government Code of 1991 provides that a local government unit, pursuant to an ordinance, may temporarily close roads within its jurisdiction.

WHEREFORE, on motion of SP Member Vivencio Q. Lozares, Jr. duly seconded by SP Member Richard R. Parin,

BE IT ENACTED by the Sangguniang Panlungsod of General Trias in Session assembled, that:

SECTION 1. TITLE. "Declaring the Temporary Closure of San Juan-Tejero NIA Road".

Page 2 of City Ordinance No. 19-09 (General):

SECTION 2. ROAD CLOSURE DETAILS. The San Juan-Tejero NIA Road will be temporary closed to vehicular traffic for 120 calendar days starting 01 September 2019 for the construction of its drainage canal to prevent standing water and avoid flooding.

Section 3. REPEALING CLAUSE. All existing ordinances, resolutions, motion or parts thereof not consistent herewith are hereby repealed, amended or superseded accordingly.

Section 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval.
