TEMPORARILY CLOSING SEVERAL AREAS IN DIFFERENT BARANGAY IN THE CITY IN THE MORNING UNTIL NOON OF WEDNESDAY, 02 OCTOBER AND THE WHOLE DAYS OF FRIDAY AND SATURDAY, 11-12 OCTOBER TO PAVE THE WAY FOR THE CONDUCT OF THE REHEARSAL AND PROGRAM PROPER IN THE CELEBRATION OF THE 150TH BIRTH ANNIVERSARY OF GENERAL MARIANO CLOSAS TRIAS.

WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit may, pursuant to an ordinance, temporarily close any local road;

WHEREAS, the Sangguniang Panlungsod passed an Ordinance giving way to the commemoration of the 150th Birth Anniversary of General Mariano Closas Trias on 12 October 2019;

WHEREAS, the National Historical Commission (NHC) of the Philippines will be hosting the program with the full support of the Local Government Unit;

WHEREAS, during the rehearsal and celebration, it is deemed necessary to close roads for the preparation and solemn commemoration of the event;

WHEREFORE, on motion of SP Member Richard R. Parin duly seconded by SP Member Hernando M. Granados,

BE IT ENACTED by the Sangguniang Panlungsod of General Trias in Session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as "Temporary Closure of Some Areas in Different Barangay in the City for the Celebration of the 150th Birth Anniversary of Gen. Mariano C. Trias".

SECTION 2. REGULATED ACTS. The following areas in different Barangay in the City shall be closed in the morning until noon of Wednesday, 02 October and the whole days of Friday and Saturday, 11-12 October to pave the way for the conduct of the Rehearsal and Program Proper in the celebration of the 150th Birth Anniversary of General Mariano Closas Trias:

02 October

- a. Barangay Arnaldo (Alfamart)
- b. Barangay Gov. Ferrer (In front of Barangay Hall)

- d. Barangay Bagumbayan (Going to 7-Eleven, One-way)
- e. Barangay Sampalucan (Public Market going to Shell Gasoline Station, One-way)

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval thereof.






