GRANTING THE AMOUNT OF FIVE HUNDRED PESOS (PHP 500.00) AS ANNUAL BIRTHDAY GIFT TO ANY SENIOR CITIZEN IN THE CITY OF GENERAL TRIAS.

WHEREAS, pursuant to Article XV, Section 4 of the 1987 Philippine Constitution, it is the duty of the family to take care of its elderly members while the State may design programs of social security for them;

WHEREAS, pursuant to Republic Act No. 9994 otherwise known as the Expanded Senior Citizens Act of 2010, the City of General Trias acknowledges and recognizes the integral role of senior citizens and honors such legacy of elderly people.

WHEREAS, in consideration of the above provisions and in appreciation of the senior citizens' contribution to the society, the Sangguniang Panlungsod deemed it proper and appropriate to grant birthday cash gift amounting to Five Hundred Pesos (Php 500.00) to all senior citizens in the City of General Trias;

WHEREFORE, on motion of SP Member Jowie S. Carampot duly seconded by SP Member Walter C. Martinez,

BE IT ENACTED by the Sangguniang Panlungsod, that:

SECTION 1. TITLE. This Ordinance shall be known as the "SENIOR CITIZEN BIRTHDAY GIFT ORDINANCE".

SECTION 2. REQUISITES. Any senior citizen residing in the City of General Trias and has an Identification Card issued by the Office of the Senior Citizens Affairs (OSCA) of General Trias shall be qualified for the birthday cash gift amounting to Five Hundred Pesos (Php 500.00).

SECTION 3. IMPLEMENTING AGENCY. The Office of the City Mayor shall form and spearhead a committee in coordination with the Office of the Senior Citizens Affairs (OSCA), the City Social Welfare and Development Office (CSWDO) and the Sangguniang Panlungsod Committee on Elderly to execute this Ordinance.
