PRESCRIBING NEW FARE MATRIX FOR TRICYCLES IN THE CITY OF GENERAL TRIAS DURING THE IMPOSITION OF GENERAL COMMUNITY QUARANTINE (GCQ).

WHEREAS, there is a need to adjust the current tricycle fare matrix in the City considering the limited number of passenger that tricycle can load per trip in relation to the emergence of national state of emergency;

WHEREAS, the City officials have studied thoroughly the situation of tricycle operators under the General Community Quarantine (GCQ) and came up with the holistic solution that is fair for both the riding public and the tricycle drivers/operators;

WHEREFORE, on motion of SP Member Isagani L. Culanding duly seconded by SP Member Florencio D. Ayos,

Be it ordained by the Sangguniang Panlungsod, that

**ARTICLE I
GENERAL PROVISIONS**

SECTION 1. TITLE. This Ordinance shall be known as the "Tricycle Fare Matrix in the City during General Community Quarantine (GCQ) Ordinance".

SECTION 2. DECLARATION OF POLICY. As provided in the Local Government Code of 1991 (RA 7160), it is hereby declared the policy of the city to protect more the welfare of the public, and tricycle drivers/operators by regulating the operations of tricycles during the time when general community quarantine (GCQ) is imposed in the City.

SECTION 3. DEFINITION OF TERMS.

- 3.1 GENERAL COMMUNITY QUARANTINE (GCQ)** - the implementation of temporary measures limiting movement and transportation, regulation of operating industries, and presence of uniformed personnel to enforce community quarantine protocols,
- 3.2 TRICYCLE** - a motor vehicle composed of a motorcycle fitted with a single-wheeled sidecar or a motorcycle with a two-wheel cab operated to render transport services to the general public, and

3.3 FARE MATRIX – list of amount incurred/imposed for a trip from origin to destination.

SECTION 4. COVERAGE. This Ordinance shall apply to all riding public and motorized tricycles' (including back to back type) drivers/operators within the territorial jurisdiction of the City of General Trias.

- 4.1 Minimum of Twenty Five Pesos (Php 25.00) for first three (3) kilometres and additional Two Pesos (Php 2.00) for every succeeding kilometre,
- 4.2 All tricycles drivers/operators are mandated/required to give fare discounts to elderly, disabled persons and students in the amount equivalent to 20% of the authorized fare, and
- 4.3 Fare Matrix shall be displayed inside the vehicles for the information of the passengers.

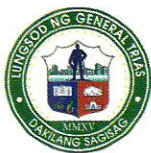

ARTICLE III
ADMINISTRATIVE PROVISIONS

SECTION 6. ENFORCEMENT AND IMPLEMENTATION. This Ordinance shall be implemented by the Office of the City Mayor, Personnel of General Trias City Police, City Traffic Management Office (CTMO), Barangay Officials and other offices or personnel as may be deputized by the Local Chief Executive.

SECTION 7. PENALTY. The violators of this Ordinance shall be penalized as follows:

First Offense	-	Fine of Php 500.00
Second Offense	-	Fine of Php 1 000.00
Third Offense	-	Fine of Php 2 000.00

All fines/penalties payable shall be paid directly to the Office of the City Treasurer which transaction shall be evidenced by the corresponding Official Receipt.

ARTICLE IV
FINAL PROVISIONS

SECTION 8. REPEALING CLAUSE. All orders, memoranda, rules and regulations, or any part or parts hereof, inconsistent with the provisions of this Ordinance are hereby revoked or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE. If for any reason a provision of this Ordinance is declared invalid or unconstitutional, all other provisions hereof not affected thereby shall continue to be in full force and effect.

SECTION 10. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.

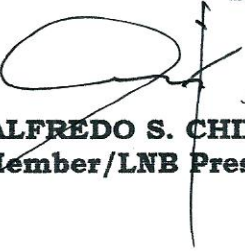

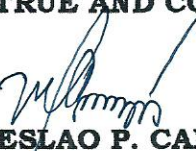

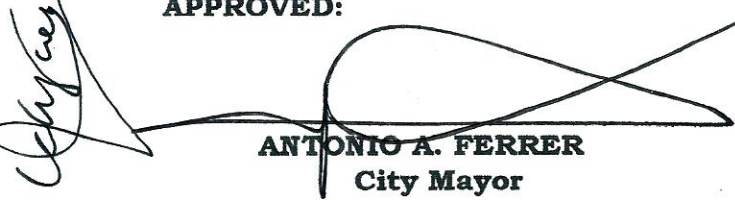
