DECLARING A THREE-YEAR MORATORIUM IN THE ISSUANCE OF BUSINESS AND OTHER RELATED CITY PERMITS FOR NEW JUNKSHOPS/SCRAPPERS TO BE ESTABLISHED WITHIN THE CITY OF GENERAL TRIAS, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall exercise powers which are essential to the promotion of the general welfare. Further, it shall ensure and support the promotion of the health and safety, enhance the right of the people to a balanced ecology, and preserve the comfort and convenience of its inhabitants;

WHEREAS, the proliferation of junkshops/scrappers along main and secondary roads in the City of General Trias contributes to the clogging of vehicular traffic and diminishes the aesthetic value of communities;

WHEREAS, in order for the City Government to effectively regulate the operations of aforesaid registered junkshops/scrappers, prevent possible violations of pertinent environmental laws, and prevent the worsening of traffic conditions in the City, there is a need to temporarily cease the issuance of business permits and other related permits to new junkshops/scrappers businesses;

NOW THEREFORE, on motion of SP Member Alfredo S. Ching duly seconded by SP Member Jesse Raphael R. Grepo,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as the "JUNKSHOPS/SCRAPPERS MORATORIUM OF THE CITY OF GENERAL TRIAS ORDINANCE".

SECTION 2. DEFINITION OF TERMS

a. Junkshop/Scrapper - an establishment engaged in the



collection, reprocessing, recycling and selling of used items,

- a.1 Existing Junkshop/Scrapper - a junkshop /scrapper with pertinent permits from the local government unit which is currently operating in the City,
- a.2 New Junkshop Operator/Scrapper - a junkshop/ scrapper intends to be established as a business in the City; and those currently operating without the necessary permits from the LGU, and
- b. Moratorium - a temporary prohibition of an activity.

SECTION 3. MORATORIUM DECLARATION AND COVERAGE - A three-year moratorium in the issuance of new business permits and other related City permits and clearances in favor of operators of junkshops/scrappers that are intended to be established after the date of effectivity of this Ordinance is hereby declared, provided that existing registered junkshops/scrappers already operating prior to the date of effectivity of this Ordinance shall not be covered by the said moratorium, provided further that none of the existing registered junkshops/scrapper operators shall be allowed to open branches, extensions, and annexes of their existing business that is intended to circumvent this Ordinance.

SECTION 4. MORATORIUM LIFTING OR EXTENSION - The lifting or extension of the three-year moratorium shall depend on the results of the joint review to be conducted by the Sangguniang Panlungsod Committee on Environmental Protection, Natural Resources and Ecology, and the City Environment and Natural Resources Office (CENRO).

SECTION 5. PENALTIES - The following penalties shall be imposed against any junkshop/scrapper operator who violates this Ordinance and shall be meted the following penalties:

First Offense	: Fine of Two Thousand Pesos (Php 2 000.00) and 2-week temporary closure,
Second Offense	: Fine of Three Thousand Pesos (Php 3 000.00) and 3-week temporary closure, and
Third Offense	: Five Thousand Pesos (Php 5 000.00) and permanent closure.

SECTION 6. IMPLEMENTING OFFICE - The Business Permit and Licensing Office (BPLO), the City Environment and Natural Resources Office (CENRO) and Barangay LGUs shall ensure the strict implementation of the provisions of the Ordinance.

SECTION 7. IMPLEMENTING RULES AND REGULATIONS - While the provisions of this Ordinance are executory, the City Mayor may formulate implementing rules and regulations as may be deemed necessary.

SECTION 8. SEPARABILITY CLAUSE - If for any reason of reasons, any part of the provisions of this Ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be full force and effect.

SECTION 9. REPEALING CLAUSE – All ordinances, resolutions, circulars, letters of the instruction, memorandums, and rules and regulations inconsistent with the provision of the Ordinance are hereby repealed and modified accordingly.

SECTION 10. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon its posting at three (3) conspicuous places within the City.


