CONSIDERATELY EXTENDING THE DEADLINE UNTIL 17 MARCH 2023 FOR THE PAYMENT OF TAXES, FEES, AND CHARGES IN THE RENEWAL OF BUSINESS PERMITS IN THE CITY OF GENERAL TRIAS WITHOUT SURCHARGES AND PENALTIES.

WHEREAS, through a letter to the Sanggunian, the Honorable Luis "Jon-Jon" A. Ferrer IV, City Mayor requested the extension of the schedule of payment in the renewal of business permits in the City;

WHEREAS, for the past years, the practice and consideration in extending the schedule of payment of taxes and fees without surcharges and penalties have favored the City Government and the taxpayers in terms of tax collection and processing of requirements;

WHEREAS, at present, the minimum health standards on COVID-19 being implemented still affect the operations of the City Government which include but are not limited to the collection of taxes and other fees and charges;

WHEREAS, the extension of such deadline will effectively decrease the volume of taxpayers transacting with the City Government;

WHEREAS, the abovementioned scheme in the schedule of paying taxes and fees will help more than 7000 registered business establishments in the City providing them ample time in meeting the deadline of complying with the requirements;

WHEREAS, Chapter 3, Section 167 of the Local Government Code of 1991 (RA 7160) provides that the Sanggunian may, for a justifiable reason or cause, extend the time of payment of taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREFORE, on motion of SP Member Felix A. Grepo duly seconded by SP Member Jesse Raphael R. Grepo, be it

ENACTED, AS IT IS HEREBY ENACTED by the Sangguniang Panlungsod of General Trias in Session assembled, that:

Section 1. TITLE – The Sanggunian considerately extends the schedule of payment of business taxes and fees without surcharges and penalties in the City of General Trias until 17 March 2023. This will be known as the "Extended Schedule of Taxes and Fees Payment" Ordinance.

Section 2. EFFECTIVITY CLAUSE – This Ordinance shall take effect after the posting of copies in conspicuous places in the city has been undertaken.
