GRANTING CASH INCENTIVES TO ANY INDIVIDUALS FROM THE CITY OF GENERAL TRIAS FOR WINNING EVERY GOLD, SILVER OR BRONZE MEDAL IN PALARONG PAMBANSA.

WHEREAS, Article XIV, Section 19 of the 1987 Philippine Constitution provides that the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, Palarong Pambansa is an annual multisport event involving student athletes from the eighteen (18) regions in the Philippines, organized and governed by the Department of Education (DepEd);

WHEREAS, the objectives of the Palarong Pambansa are to:

- 1. Promote the Physical Education and Sports as an integral part of the Basic Education curriculum for holistic development of the youth,**
- 2. Inculcate the spirit of discipline, teamwork, excellence, fair play, solidarity, sportsmanship, and other values inherent in sports,**
- 3. Promote and achieve peace by means of sports,**
- 4. Widen the base for talent identification, selection, recruitment, training and exposure of elementary pupils and secondary students to serve as a feeder to the National Sports Association (NSA) for international competitions, and**
- 5. Provide a database for a valid and universal basis to further improve the school sports development programs;**

WHEREAS, winning any medal in the Palarong Pambansa brings with it pride and honor;

WHEREFORE, on motion of SP Member Hernando M. Granados duly seconded by SP Member Christopher N. Custodio,

Be it enacted by the Sangguniang Panlungsod, that:

Section 1. SHORT TITLE. This Ordinance shall be known as the "Palarong Pambansa Incentive Ordinance of the City of General Trias".

Section 2. DECLARATION OF POLICY. It is the policy of the Local Government Unit of General Trias to encourage, recognize, and reward any

individuals or team athletes winning the Top Three Positions in different regular sports events and the demonstration sports in the Palarong Pambansa.

Section 3. PURPOSE. The main objective of this Ordinance is to prescribe the scheme for the recognition and rewarding of any Gentriseños who will win the bronze, silver, and gold medals in the Palarong Pambansa. The Ordinance likewise supports and recognizes the city slogan, "Galíng Gentri, Gáling Gentri".

Section 4. DEFINITION OF TERMS.

- a. **Palarong Pambansa** - an annual multisport event involving student-athletes from 18 regions of the Philippines. The event is organized and governed by the Department of Education (DepEd). Student-athletes from public and private schools at elementary and secondary levels can compete provided they qualified by winning at their regional meets.
- b. **City Sports Council** - the city overseer of all programs, projects, and activities concerning sports in the City of General Trias.
- c. **Regular Sports Events** - the official sports events in the Palarong Pambansa.
- d. **Demonstration Sports** - other games or events aside from the regular sports events played in Palarong Pambansa for the purpose of their promotion and as a tool to discover promising talents in these events for future international competitions.

Section 5. COVERAGE. This Ordinance shall cover all Gentriseños winning in the Palarong Pambansa.

Section 6. INCENTIVES AND BENEFITS. In recognition of the accomplishment in winning top positions in the Palarong Pambansa, any Gentriseños, be it in individual or team who shall win the bronze, silver, and gold medals shall be entitled to the following cash incentives:

1. **Regular Sports Events**
 - a. Php 20 000.00 - Gold Award/First Place
 - b. Php 10 000.00 - Silver Award/Second Place
 - c. Php 5 000.00 - Bronze Award/Third Place
2. **Demonstration Sports**
 - a. Php 10 000.00 - Gold Award/First Place
 - b. Php 5 000.00 - Silver Award/Second Place
 - c. Php 3 000.00 - Bronze Award/Third Place

Section 7. RULES AND REGULATIONS. The Office of the City Mayor through the City Sports Council is tasked to formulate guidelines for the purpose.

Section 8. FUNDING/SPECIAL SPORTS FUND. For the purpose of this Ordinance, incentives shall be appropriated from the General Fund of the City.

Section 9. SUPPLEMENTARY CLAUSE. On matters not provided in this Ordinance, any existing applicable laws and their corresponding implementing rules and regulations, executive orders, and relevant issuances issued therefore shall be applied in a supplemental manner.

Section 10. SEPARABILITY CLAUSE. If for any reason or reasons, any part or provision hereof shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected hereby shall continue to be in full force and effect.

Section 11. REPEALING CLAUSE. All ordinances, resolutions or laws of local application and effect inconsistent hereto are hereby modified, superseded and repealed accordingly.

Section 12. EFFECTIVITY. This Ordinance shall take effect ten (10) days after publication in at least two (2) newspapers of local circulation or posting requirements under RA 7160.


