CONSIDERATELY EXTENDING THE SCHEDULE OF PAYMENT OF BUSINESS TAXES AND FEES WITHOUT SURCHARGE AND PENALTIES IN THE CITY OF GENERAL TRIAS UNTIL 08 FEBRUARY 2019.

WHEREAS, based on feedback and records, the extension of the schedule of payment of taxes and fees without surcharges and penalties has definitely favored the city government and the taxpayers in terms of tax collection and processing of requirements;

WHEREAS, for the past years, the practice and consideration of extending the schedule of payment of taxes has addressed the common problems met by both the business establishments and the city government;

WHEREAS, Chapter 3, Section 167 of the Local Government Code of 1991 (RA 7160) provides that the Sanggunian may, for a justifiable reason or cause, extend the time of payment of taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Hernando M. Granados, be it

ENACTED, AS IT IS HEREBY ENACTED by the Sangguniang Panlungsod of General Trias in Session assembled, that:

Section 1. TITLE - The Sanggunian considerably extends the schedule of payment of business taxes and fees without surcharge and penalties in the City of General Trias until 08 February 2019. This will be known as "Extended Schedule of Tax and Fees Payment" Ordinance.

Section 2. EFFECTIVITY CLAUSE - This Ordinance shall take effect after posting of copies in conspicuous places in the city has been undertaken.


