REQUIRING ALL BUSINESS ENTERPRISES SUCH AS MONEY TRANSFER SERVICE, ONLINE PURCHASE DELIVERIES, GROCERIES AND SUPERMARKETS DELIVERIES TO PRESENT THEIR QUARANTINE PASS AS THEY CONDUCT BUSINESS IN THE CITY AND PENALIZING VIOLATORS THEREOF.

WHEREAS, President Rodrigo Roa Duterte issued Proclamation No. 922 declaring a Public Health Emergency throughout the Philippines due to Coronavirus Disease 2019 (COVID-19);

WHEREAS, Luzon was placed under an enhanced community quarantine (ECQ) strengthening the social distancing measures including closure of business establishments other than those providing basic necessities such activities related to food, medicine and financial transactions;

WHEREAS, to effectively implement the community quarantine, every household in a barangay in the City of General Trias was issued with one nontransferrable home quarantine pass (HQP) with corresponding control number that allows a designated household member to go outside of their residence;

WHEREAS, during the imposition of the ECQ, there is an increase demand of acquiring goods through delivery services,

WHEREAS, essential business establishments in the City of General Trias are still operating despite the imposition of lockdown to provide the necessities of the people thus allowing their employees from different cities/municipalities to report to work;

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Richard R. Parin,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as "Requiring All Business Enterprises Such as Money Transfer Service, Online Purchase Deliveries, Groceries and Supermarkets Deliveries to Present Their Quarantine Pass as they Conduct Business in the City and Penalizing Violators Thereof".

Continuation...page 2 of City Ordinance No. 20-23 (General):

SECTION 2. REGULATED ACT - All business enterprises such as money transfer service, online purchase deliveries, groceries and supermarkets deliveries shall need to present their home quarantine pass in every checkpoint areas as they conduct business in the City of General Trias during the imposition of enhanced community quarantine.

SECTION 3. ENFORCEMENT - This Ordinance shall be implemented by the City PNP, Barangay Officials, AFP and other personnel to be assigned in every checkpoint areas thereat.

SECTION 4. PENALTIES - Any person who violates this Ordinance shall be penalized, as follows:

1st Offense : Reprimand,

2<sup>nd</sup> Offense: Fine of Php 1 000.00, and

3rd Offense: Fine of Php 5 000.00

SECTION 5. SEPARABILITY CLAUSE - If, for any reasons, any part or provision of this Ordinance shall be unconstitutional or invalid, other parts or provision hereof, which are not affected thereby, shall continue to be in full force and effect.

SECTION 6. REAPEALING CLAUSE - All Ordinances inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately and shall remain in force until the enhanced community quarantine shall have been lifted.
