MANDATING THE SCHEDULES OF PUBLIC AND PRIVATE MARKETS, GROCERY STORES, TALIPAPA AND SUPERMARKETS IN THE CITY OF GENERAL TRIAS DURING THE IMPOSITION OF ENHANCED COMMUNITY QUARANTINE.

WHEREAS, to effectively contain the spread of Coronavirus Disease 2019 (COVID-19), strict implementation and practice of social distancing is necessary;

WHEREAS, places such as markets, talipapa, grocery stores and supermarkets where people buy basic commodities are getting crowded that could result to the spread of virus;

WHEREAS, to ensure proper social distancing and to prevent the spread of COVID-19, the gathering of people in the abovementioned places must be controlled;

WHEREAS, an advisory from the Department of Interior and Local Government (DILG) states that scheduling and/or clustering of the communities or barangay who may be allowed to go outside is highly encouraged;

WHEREAS, to further strengthen the enforcement of the rule on social distancing in public and private places without compromising the right to avail basic necessities, marketing schedules are necessary;

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Gary A. Grepo,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as "Market Day Schedules in the City of General Trias During the Imposition of Enhanced Community Quarantine".

SECTION 2. REGULATED ACT - All markets in the City of General Trias shall have market day schedules for the customers.

The City will use the surname written in the home quarantine pass in alphabetical order as basis of market day schedules.

Continuation...page 2 of City Ordinance No. 20-27 (General):

The groceries stores, supermarket and talipapa owners shall determine their Operation Hours and put notice signage in front of their establishments. In addition, frontliners will have their own assigned market day.

SECTION 3. MARKET DAY SCHEDULES - Based in alphabetical orders of customer surnames indicated in the home quarantine pass, the market day schedules for public and private markets, talipapa, grocery stores and supermarkets are as follows:

MONDAYS : Frontliners (Medical and Non-Medical),

TUESDAYS, THURSDAYS & SATURDAYS : Surnames beginning in letters A to L, and

WEDNESDAYS, FRIDAYS & SUNDAYS : Surnames beginning in letters M to Z.

SECTION 4. ENFORCEMENT - This Ordinance shall be implemented by the Office of the City Mayor through the Market Administrator, City PNP, Barangay Officials, AFP and other personnel to be assigned thereat.

SECTION 5. PENALTIES - Any person who violates this Ordinance will be penalized with the following fines and/or penalties:

1st Offense : Reprimand,

2nd Offense : Fine of Php 1 000.00, and

3rd Offense : Fine of Php 5 000.00

SECTION 6. SEPARABILITY CLAUSE - If, for any reasons, any part or provision of this Ordinance shall be unconstitutional or invalid, other parts or provision hereof, which are not affected thereby, shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE - All ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately and shall remain in effect until the enhanced community quarantine shall have been lifted.




