CONSIDERATELY EXTENDING THE SCHEDULE OF PAYMENT OF BUSINESS TAXES AND FEES DUE FOR THE 2ND QUARTER OF 2020 WITHOUT SURCHARGES AND PENALTIES IN THE CITY OF GENERAL TRIAS UNTIL 15 JULY 2020.

WHEREAS, in consideration of the impact of the Coronavirus Disease 2019 (COVID-19) to local businesses, the payment without penalty of business taxes in the City of General Trias due for the 2nd Quarter of 2020 is extended until 15 July 2020;

WHEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Richard R. Parin, be it

Be it enacted by the Sangguniang Panlungsod in Regular Session assembled, that:

SECTION 1. COVERAGE. All annual and quarterly taxes, fees, and charges due and payable to the City Government for the 2nd Quarter of the current year can be paid not later than 15 July 2020 without penalties, surcharges, or interest.

SECTION 2. PENALTIES AND INTEREST. All taxes, fees, and charges due for the 2nd Quarter of the current year shall, however, be subject to those penalties and interest prescribed in the City Revenue Code if not paid on or before 15 July 2020.

SECTION 3. REPEALING CLAUSE. Any provisions of ordinances, executive orders, issuances or rules and regulations inconsistent with the provisions of this Ordinance is hereby repealed, amended, or modified accordingly.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
