ADOPTING EXECUTIVE ORDER NO. 33 SERIES OF 2019: STREAMLINING THE PROCESS OF SECURING BUSINESS PERMIT PROMOTING THE EASE OF DOING BUSINESS IN THE CITY OF GENERAL TRIAS; AND PRESCRIBING THE INCLUSION OF BEVERAGES BUSINESS AND BARANGAY COUNCILOR (CHAIRMAN, COMMITTEE ON BUSINESS) IN SECTION 4 AND SECTION 7 THEREIN, RESPECTIVELY.

WHEREAS, in streamlining the processes of securing business permit in compliance to national laws, Republic Act No. 11032 known as "Ease of Doing Business and Efficient Government Service Delivery Act of 2018" in particular, the Local Chief Executive issued Executive Order No. 33 Series of 2019;

WHEREAS, the implementation of Executive Order No. 33 Series of 2019 will redound to the benefits of the Gentriseños in terms of fast and lower cost transaction of securing business permit;

WHEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Jowie S. Carampot,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as the "ADOPTING EASE OF DOING BUSINESS ORDINANCE".

SECTION 2. OBJECTIVES - This Ordinance aims to provide the public with quality government service as fast as possible while substantially reducing expenses, inconvenience and wasted time. Ease of doing business also encourages competitiveness and improves the overall business environment.

SECTION 3. SUPPLEMENTAL PROVISIONS - Businesses engaged in beverages shall be included in the list of critical/high-risk businesses enumerated in Section 4 of Executive Order No. 33 Series of 2019.

Additionally, it is also recommended to include the Barangay Councilor (Chairman, Committee on Business) in the provision of Section 7 of Executive Order No. 33 Series of 2019.

SECTION 4. IMPLEMENTING RULES AND REGULATIONS - While the provisions of this Ordinance are operative and self-executory, an Implementing

Rules and Regulations may be issued by the Local Chief Executive as may be deemed necessary.


SECTION 5. REPEALING CLAUSE - All orders, memoranda, rules and regulations, or any parts hereof, inconsistent with the provisions of this Ordinance are hereby revoked or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE - If for any reason a provision of this Ordinance is declared invalid or unconstitutional, all other provisions hereof, not affected thereby, shall continue to be in full force and effect.

SECTION 7. EFFECTIVITY - This Ordinance shall take effect immediately upon its approval.




