PROVIDING FINANCIAL ASSISTANCE TO ALL PRIVATE SCHOOL TEACHERS WHO ARE RESIDENTS OF THE CITY OF GENERAL TRIAS, AND CURRENTLY TEACHING IN PRIVATE SCHOOLS WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF GENERAL TRIAS AFFECTED BY THE CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC; AND APPROPRIATING FUNDS NECESSARY THEREOF.

WHEREAS, due to the current pandemic, the private schools are facing critical economic conditions since most of the students have transferred to public schools thereby decreasing the number of enrollees and affecting the salaries of the teachers;

WHEREAS, teachers from different private schools continue to work countless hours creating lessons and investing on supplies and gadgets from their personal money to step up and fulfill their unprecedented roles in the "new normal" classroom set-up;

WHEREAS, the teachers, despite the challenges and struggles brought by pandemic, continue to have strong driving force in raising the quality of education in the City;

WHEREAS, private school teachers are also in need of assistance for the acquisition of equipment, internet access, and other materials needed for online teaching;

WHEREAS, as provided in Section 3 (a) of Republic Act No. 11494, also known as Bayanihan to Recover as One Act, "it is declared as the policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free and people from poverty, particularly in the aftermath of natural and man-made disasters, through policies that provide adequate social services, and promote full employment, a rising standard of living, and an improved quality of life for all. The State shall likewise establish

mechanisms to reduce the adverse impact of COVID-19 on the socioeconomic well-being of all Filipinos through the provision of assistance, subsidies, and other forms of socioeconomic relief":

WHEREAS, with the "no work, no pay" policy, private school teachers have been adversely affected by the Corona Virus Pandemic;

WHEREFORE, on motion of SP Member Vivencio Q. Lozares Jr. duly seconded by SP Member Walter C. Martinez,

Be it enacted by the Sangguniang Panlungsod of General Trias, that:

SECTION 1. TITLE. This Ordinance shall be known as "COVID-19 Financial Assistance to Private School Teachers in the City of General Trias Affected by Coronavirus Pandemic Ordinance".

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the City of General Trias to protect the welfare of the private school teachers within the territorial jurisdiction who are affected by the Coronavirus Pandemic.

SECTION 3. DEFINITION OF TERMS.

PRIVATE SCHOOL - educational learning institution which is administered and operated by the private sector, private individual,

PANDEMIC - an outbreak of a disease that occurs over a wide geographic area and affects an exceptionally high proportion of the population,

CORONAVIRUS DISEASE 2019 (COVID-19) - is an infectious disease caused by Severe Acute Respiratory Syndrome Coronavirus 2 (SARS-CoV-2), and

TEACHER - a person who helps students to acquire knowledge, competence, or virtue.

SECTION 4. COVERAGE. all private school teachers who are residents of the City of General Trias, currently teaching in private schools within the territorial jurisdiction of the City of General Trias, and affected by the Coronavirus Pandemic shall be covered by this Ordinance.

SECTION 5. REQUIREMENTS. All the qualified private teachers in the City of General Trias must submit the following:

- 1. Certificate of Employment and /or current School I.D.,
- 2. Barangay Certification, and
- 3. Copy of Latest Comelec Voters Registration Record (VRR).

SECTION 6. ENFORCEMENT OR IMPLEMENTATION. This Ordinance shall be implemented by the Office of the City Mayor through the City Treasurer's Office and other office or personnel as may be deputized by the Local Chief Executive.

SECTION 7. BUDGET. The necessary funds to implement this Ordinance shall be appropriated from the General Fund of the City Government.

SECTION 8. SEPARABILITY CLAUSE. If for any reason, any parts or provisions of this Ordinance shall be declared unconstitutional or invalid, other parts that are not affected thereof shall continue to be in full force and effect.

SECTION 9. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.
