REPEALING ARTICLE B OF CHAPTER VI OF MUNICIPAL ORDINANCE NO. 15-05 ALSO KNOWN AS THE REVISED REVENUE CODE OF THE MUNICIPALITY OF GENERAL TRIAS THEREBY REMOVING THE COLLECTION OF GARBAGE FEE BEING IMPOSED BY THE CITY GOVERNMENT TO BUSINESS ESTABLISHMENTS.

WHEREAS, as provided in Section 6B.01 and Section 6B.02 of Article B of Chapter VI, there shall be collected from every owner or operator of a business, establishment an annual garbage fee in accordance with the prescribed schedule;

WHEREAS, based on its findings, the local government is spending more for the garbage collection services than the garbage fees being collected from the operators and owners of business establishments in the City;

WHEREAS, the solution to the problem of the City Government on garbage collection services expenditures is the removal of the corresponding fees provided in the Revenue Code, thus, requiring operators and owners of business establishments to contract for themselves or have their own garbage hauler for the waste/garbage generated;

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Kristine Jane M. Perdito-Barison,

Be it enacted by the Sangguniang Panlungsod, that;

SECTION 1. PROVISION - Article B of Chapter VI of Municipal Ordinance No. 15-05 Pertaining to Service Charge for Garbage Collection is hereby repealed in its entirety.

SECTION 2. REGULATED ACT - Operators and owners of business establishments are hereby required to contract for themselves or have their own garbage hauler for the waste or garbage generated.

SECTION 3. REPEALING CLAUSE - This Ordinance does not in any manner repeal, amend or modify the provisions of Municipal Ordinance No. 15-05.
