WAIVING THE TEN PERCENT (10%) AMUSEMENT TAX OF ROBINSONS MOVIE THEATER TICKETS AVAILED BY SENIOR CITIZENS (SCs) AND PERSONS WITH DISABILITIES (PWDs) OF THE CITY OF GENERAL TRIAS SUBJECT TO ALL LAWS AND EXISTING LEGAL RULES AND REGULATIONS.

WHEREAS, with utmost concern to the Senior Citizens (SCs) and Persons With Disabilities (PWDs), the City Government of General Trias wants to provide the SCs and the PWDs better privileges aside from the twenty percent (20%) discount privilege granted by the national laws;

WHEREAS, movie going has always been a good form of relaxation to many Filipinos and a source of educational information especially on relevant social issues;

WHEREAS, the City Government of General Trias and Robinsons Land Corporation have mutually agreed to grant free movie privileges to Senior Citizens and Persons With Disabilities of the city;

WHEREAS, on 20 December 2016, Resolution No. 02-2016-117 authorizing the Local Chief Executive to represent the Local Government Unit (LGU) of General Trias to sign and enter into a Memorandum of Agreement with the Robinsons Land Corporation regarding free movie access for senior citizens and persons with disabilities was approved;

WHEREAS, Section 192 of the Local Government Code of 1991 (RA 7160) states that local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary;

NOW, THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by all Members present,

Be it enacted by the Sangguniang Panlungsod, that:

Section 1. TITLE. This Ordinance shall be known as WAIVING OF TEN PERCENT (10%) AMUSEMENT TAX OF ROBINSONS MOVIEWORLD ORDINANCE.

Section 2. WAIVING OF AMUSEMENT TAX. The city government shall waive the ten percent (10%) Amusement Tax of Robinsons Movieworld after the actual admission price less the TWENTY PERCENT (20%) discount under RA 9257 and RA 9442.

Page 2 of City Ordinance No. 17-05 (Special):

During the period of availment of Robinsons Land Corporation of the Business Tax exemptions, granted under the Investment and Incentives Code of 2014 of the City of General Trias pursuant to Municipal Ordinance No. 14-10, the forty percent (40%) share of the net movie admission cost to be shouldered by the city government will be reimbursed by way of deduction from or credit against any local tax liability of Robinsons Land Corporation.

Section 3.EFFECTIVITY CLAUSE. This Ordinance shall take effect on JANUARY 2017.
