SUSPENDING THE COLLECTION OF FEES PERTAINING TO TRICYCLE FRANCHISE (CHAPTER 4, ARTICLE N. OTHER FEES AND TRICYLE OPERATIONS OF MUNICIPAL ORDINANCE NO. 15-05: REVENUE CODE) FOR THE YEAR 2021 DUE TO CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC.

WHEREAS, the City Government has considered the difficult economic conditions experienced by the tricycle operators and the decreased number of passengers using public transportation due to the threat of the Coronavirus Disease 2019 (COVID-19);

WHEREAS, the City Government takes into account that the lockdown protocols implemented during the quarantine period has affected the income of the public transport operators;

WHEREAS, the City Government ought to extend assistance to the affected drivers by waiving the collection of payment on Mayor's Permit/Sticker, Filing Fee, Legal Research Fund Fee and Motorized Tricycle Operator's Permit (Franchise Fee) for the year 2021;

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Isagani L. Culanding,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. TITLE – This Ordinance shall be known as "Suspension of the Collection of Fees Pertaining to Tricycle Franchise for the Year 2021".

SECTION 2. PROVISION - The collection of the following Taxes/Fees on Business of Operating Motorized Tricycle (Franchise/MTOP) as provided in Article E of Revenue Code of 2015 is hereby suspended:

- a. Mayor's Permit/Sticker,
- b. Filing Fee,
- c. Legal Research Fund Fee, and
- d. Motorized Tricycle Operator's Permit (MTOP) (Franchise Fee).
