AMENDING CITY ORDINANCE NO. 18-03 (TAX): SETTING THE GUIDELINES, POLICIES, RATES, AND FEES FOR AVAILING NEWLY CONSTRUCTED APARTMENT UNITS AT HIMLAYANG GENERAL TRIAS (LIBINGANG BAYAN) A PUBLIC CEMETERY OWNED AND MAINTAINED BY THE CITY GOVERNMENT OF GENERAL TRIAS, WHEREBY IMPOSING ALL APPLICABLE PROVISIONS STATED THEREIN TO HINLAYANG GENERAL TRIAS BUENAVISTA ANNEX.

WHEREAS, the City Government of General Trias established, maintaining, and operating Himlayang General Trias (Libingang Bayan);

WHEREAS, the construction of new public cemetery will be a great help to the community;

WHEREAS, the Local Government Unit (LGU) constructed an additional public cemetery to be called Himlayang General Trias Buenavista Annex, and will adopt to its operation the existing guidelines in Himlayang General Trias (Libingang Bayan).

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Richard R. Parin,

Be it enacted by the Sangguniang Panlungsod of General Trias, that:

SECTION 1. TITLE - This Ordinance shall be known as the "Amended City Ordinance No. 18-03 Whereby Imposing All Applicable Provisions Stated Therein to Himlayang General Trias Buenavista Annex Ordinance"

SECTION 2. DEFINITION OF TERMS -

HIMLAYANG GENERAL TRIAS BUENAVISTA ANNEX - extended public cemetery of Himlayang General Trias (Libingang Bayan) located in Barangay Buenavista III, City of General Trias, Cavite.

SECTION 3. RATES, FEES AND CHARGES - The duration, rates, fees and charges for the use of Apartment Units at Himlayang General Trias (Libingang Bayan) shall also be implemented in Himlayang General Trias Buenavista Annex.

SECTION 4. ADMINISTRATIVE PROVISIONS – The guidelines and policies observed on the use and availment of Apartment Units at Himlayang General Trias (Libingang Bayan) shall also be observed in Himlayang General Trias Buenavista Annex.

SECTION 5. IMPLEMENTING AGENCIES – The City Government offices with the corresponding functions enumerated in City Ordinance No. 18-03 shall also be responsible for the effective implementation of this Ordinance.

SECTION 6. SEPARABILITY CLAUSE – If, for any reason, any provision, section or part of this Ordinance is declared not valid by a Court of competent jurisdiction or suspended or revoked by the authorities concerned, such judgment shall not effect or impair the remaining provisions, sections or parts which shall continue to be in force and effect.

SECTION 7. REPEALING CLAUSE – All ordinances, rules and regulations or parts thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY – This Ordinance shall take effect upon approval and after posting in three (3) conspicuous places within the City.
