**TEMPORARILY CLOSING CERTAIN PORTION OF STA. CLARA-NAVARRO-ALAPAN 2B ROAD (F. MANALO ROAD) FOR THE CONSTRUCTION OF NAVARRO BRIDGE IN BARANGAY NAVARRO STARTING ON 06 FEBRUARY 2022 UNTIL ITS COMPLETION.**

**WHEREAS, Engr. Gilberto Almanzor of the Department of Public Works and Highways (DPWH) Office of the District Engineer, Construction Section informed and requested assistance from the Local Chief Executive on the temporary closure of Sta. Clara-Navarro-Alapan 2B Road (F. Manalo Road) in relation to the construction of a bridge that will connect Barangay Navarro, City of General Trias to Barangay Alapan in City of Imus, Cavite as part of the DPWH's Local Infrastructure Program;**

**WHEREAS, Chief Almanzor assured the Local Chief Executive that installation of appropriate informative signs, devices, and public advisories on the specified location of construction should be put up;**

**WHEREAS, the temporary closure of certain portion of the above-mentioned road will fully enable the contractor to construct the Navarro Bridge for the benefit of the public;**

**WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit may, under an ordinance, temporarily close any local road;**

**WHEREFORE, on motion of SP Member Richard R. Parin duly seconded by SP Member Walter C. Martinez,**

**Be it enacted by the Sangguniang Panlungsod, that:**

**SECTION 1. SCOPE AND LIMITATION - This Ordinance shall cover certain portion of Sta. Clara-Navarro-Alapan 2B Road (F. Manalo Road) that will be declared temporarily closed from vehicular traffic starting 06 February 2022 until the completion of the construction of Navarro Bridge.**

**SECTION 2. IMPLEMENTATION** – The Office of the City Mayor through the City Engineering Office, City Traffic Management Office, and other offices as may be deputized by the City Mayor shall implement this Ordinance in coordination with the Contractor of the above-mentioned project and the Barangay Council of Navarro.

**SECTION 3. INFORMATION** – Copies of this Ordinance shall be provided to concerned offices for the information purposes and appropriate action therefor.

**SECTION 4. EFFECTIVITY CLAUSE** – This Ordinance shall take effect upon approval.
