TEMPORARILY CLOSING FROM 01 OCTOBER TO 29 DECEMBER 2023 OR UNTIL ITS COMPLETION THE SOUTHWESTERN PART OF DAANG HARI EXTENSION ROAD IN THE CITY OF GENERAL TRIAS FROM SAN JOSE TOWN HOMES TO PASONG CAMACHILE II CROSSING ADJACENT TO THE BARANGAY HALL IN RELATION TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) ROAD IMPROVEMENT THEREAT.

WHEREAS, the road improvement project of the Department of Public Works and Highways (DPWH) assured the motorists and residents of improved and more accessible route thereby boosting the economic activities in the City;

WHEREAS, there is a need to improve the southwestern part of Daang Hari Extension Road to provide passengers with a safer and more efficient transport route;

WHEREAS, temporary road closure is necessary to eliminate the exposure of motorists on work zone and allow contractors full access to roadway facilities;

WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit may, pursuant to an ordinance, temporarily close any local road;

WHEREAS, the Sanggunian deemed it necessary temporarily close the southwestern part of Daang Hari Extension Road in the City of General Trias from San Jose Town Homes to Pasong Camachile II crossing adjacent to the Barangay Hall to pave the way for the DPWH road improvement project;

NOW THEREFORE, on motion of SP Member Richard R. Parin duly seconded by SP Member Felix A. Grepo,

Be it enacted by the Sangguniang Panlungsod of General Trias, that:

Section 1. TITLE - This Ordinance shall be known as the "TEMPORARY CLOSURE OF DAANG HARI EXTENSION ROAD ORDINANCE".

Section 2. REGULATED ACTS - The southwestern part of Daang Hari Extension Road in the City of General Trias from San Homes to Pasong Camachile II crossing adjacent Jose Town to the Barangay Hall shall be temporarily closed from 01

TEMPORARY CLOSURE OF DAANG HARI EXTENSION ROAD ORDINANCE.

October to 29 December 2023 or until its completion for the DPWH road improvement thereat.

Coordination with the Offices of the City Mayor and City Traffic Management for their information shall be made regarding the traffic situations along the said area during the prescribed period.

SECTION 3. PROVISION - During the road closure, all vehicles are encourgaged to take any possible alternate route to avoid traffic congestion and delay.

Section 4. EFFECTIVITY CLAUSE - This Ordinance shall take effect upon its approval.
