AN ORDINANCE CONSIDERATELY EXTENDING THE DEADLINE UNTIL 15 MARCH 2024 FOR THE PAYMENT OF TAXES, FEES, AND CHARGES IN THE RENEWAL OF BUSINESS PERMITS IN THE CITY WITHOUT SURCHARGES AND PENALTIES.

WHEREAS, through a letter to the Sanggunian, the City Mayor Honorable Luis “Jon-Jon” A. Ferrer IV requested the extension of the schedule of payment in the renewal of business permits in the City;

WHEREAS, for the past years, the practice and consideration in extending the schedule of payment of taxes and fees without surcharges and penalties have definitely favored the City Government and the taxpayers in terms of tax collection and processing of requirements;

WHEREAS, the extension of the schedule of payment of taxes and fees without surcharges and penalties will help the registered business establishments by giving them ample time in meeting the deadline of complying with the requirements;

WHEREAS, Section 167 Chapter III of the Local Government Code of 1991 (RA 7160) provides that the Sanggunian may, for a justifiable reason or cause, extend the time of payment of taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

NOW THEREFORE, on motion of SP Member Felix A. Grepo duly seconded by SP Member Jesse Raphael R. Grepo,

Be it enacted by the Sangguniang Panlungsod, that:

Section 1. TITLE – This Ordinance shall be known as the “**EXTENDED PAYMENT SCHEDULE OF TAXES AND FEES IN THE CITY OF GENERAL TRIAS UNTIL 15 MARCH 2024 ORDINANCE**”.

Section 2. ADMINISTRATIVE PROVISION – The Sanggunian considerably extends the schedule of payment of business taxes and fees without surcharges and penalties in the City of General Trias until 15 March 2024.

Section 3. EFFECTIVITY CLAUSE – This Ordinance shall take effect after posting of copies in three (3) conspicuous places in the City has been undertaken.






