RESOLUTION NO. 47-93

WHEREAS, General Trias is now on the threshold of development. Factories are sprouting in industrial areas and so with subdivisions to support the housing needs of an increasing population due to the influx of migrant workers;

WHEREAS, commercial establishments and banking institutions are visibly in strategic places in the town to serve industrial and residential areas;

WHEREAS, with this development, concrete, asphalt and macadam roads and drainage systems within industrial areas and subdivisions are being undertaken by contract developers without paying development business tax to the local government unit.

RESOLVED, to enact an ordinance requiring contract developers to pay developer's tax before undertaking road development whether concrete, asphalt or macadam and drainage systems inside industrial and subdivision areas, to be designated as Municipal Ordinance No. 3-93, to read as follows:

MUNICIPAL ORDINANCE NO. 3-93

AN ORDINANCE PRESCRIBING BUSINESS TAX FOR CONTRACT DEVELOPERS BEFORE UNDER-TAKING ROAD DEVELOPMENT AND DRAINAGE SYSTEMS IN INDUSTRIAL AND SUBDIVISION AREAS, AND PRESCRIBING PENALTIES THEREFOR.

Be it enacted by the Sangguniang Bayan of General Trias, Cavite, that:

Section 1. - A contract developer's tax is hereby prescribed before any person, natural or juridical, can undertake any contract development of roads and drainage systems inside industrial and subdivision areas, as follows:

Length of paved/concreted/  
macadam road - - - - - ₱1.50/linear meter  
Volume of drainage systems - ₱1.50/cu. meter

Section 2. - The tax shall be paid to the Office of the Municipal Treasurer before the works are undertaken.

Section 3. - Any person who violates any provision of this Ordinance shall be punished by a fine not exceeding ₱1,000 and imprisonment of six months or both at the discretion of the Court.
