RESOLUTION NO. 1-92

RESOLVED, as it is hereby resolved, to enact an ordinance adopting Section 143, 145, 146 and 150 and Article VI of Book II of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, thus amending Municipal Ordinance No. 1-74, known as the Municipal Tax Code of General Trias, Cavite, to be read as follows:

MUNICIPAL ORDINANCE NO. 1-92

- Section 1 - This ordinance shall amend Section 19 of Municipal Ordinance No. 1-74, as amended otherwise known as the Municipal Tax Code of the Municipality of General Trias, Cavite.
- Section 2 - The Provisions of Section 143, 145, 146 and 150 and Article VI of Book II of the Local Government Code of 1991 are hereby adopted to apply to municipal taxation in the municipality.
- Section 3- All provisions of Municipal Ordinance No. 1-74, as amended which are in consistent to the provisions of the Local Government Code of 1991 are hereby repealed or amended.
- Section 4 - This ordinance shall take effect January 1, 1992.
