RESOLUTION NO. 7-2000

WHEREAS, the dumpsite in Navarro has been utilized by
the municipal government for the garbage disposal of its
residents and commercial establishments;

WHEREAS, the road leading to the dumping area is not
passable to heavy vehicles during rainy season;

WHEREAS, the government is in dire need financially
for the maintenance of an adequate garbage disposal system
and one of the sources is to impose taxes to private haulers
using the dumpsite for their waste disposal;

WHEREFORE, on motion of SB Member Felix A. Grepo duly
seconded by SB Member Armando D. Magsino,

RESOLVED, as it is hereby resolved, to enact an
ordinance requiring all private haulers to pay fee for every
trip per truck in using the dumpsite for their waste
disposal beside the annual garbage tax they paid, to be
designated as Municipal Ordinance No. 4-2000, to read as
follows:

MUNICIPAL ORDINANCE NO. 4-2000

AN ORDINANCE REQUIRING ALL PRIVATE HAULERS TO PAY FEE FOR
EVERY TRIP PER TRUCK IN USING THE DUMPSITE FOR THEIR WASTE
DISPOSAL BESIDE THE ANNUAL GARBAGE TAX THEY PAID.

Be it ordained and enacted by the Sangguniang Bayan,
General Trias, Cavite, that:

Section 1 - All private haulers are required to pay fee for every trip per truck for using the dumpsite.

Section 2 - All private haulers should pay the prescribed fees enumerated hereunder:

Kind of Vehicle/ Equipment	Classification	Capacity	Fee Per Trip
Dump Truck	10 wheeler	15-18cu.m.	P250.00
Forward	6 wheeler	10-14cu.m.	P200.00
Elf	6 wheeler	6-9 cu.m.	P150.00

Section 3 - The prescribed fees shall be paid at the Office of the Municipal Treasurer on a monthly basis.

Section 4 - This ordinance shall take effect upon its approval.
