WHEREAS, General Trias being a developing town in Cavite needs to maintain peaceful and orderly traffic situations, avoid and minimize traffic congestions;

WHEREAS, a town to be considered progressive and developed, must have an orderly, and disciplined community, where there is cooperation and understanding among its people, much more, among the drivers of all public and private vehicles;

WHEREAS, undisciplined loading and unloading of passengers of public utility vehicles on the roads of Barangay Manggahan junction prove to be the cause of traffic problems and many vehicular accidents thereat;

WHEREFORE, on motion of SB Member Carmelito B. Nocon duly seconded by all Members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED to provide loading and unloading area for public utility buses and jeepneys in Barangay Manggahan junction and be it enacted by this Body an ordinance to be designated as Municipal Ordinance No. 05-03, to be read as follows:

LOADING AND UNLOADING OF PASSENGERS OF PUBLIC UTILITY BUSES AND PUBLIC UTILITY JEEPNEYS AT THE MANGGAHAN JUNCTION.

PROVIDING FOR THE LOADING AND UNLOADING AREA OF PUBLIC UTILITY BUS AND PUBLIC UTILITY JEEP AT THE MANGGAHAN CROSSING.

Section 1. - a) All Public Utility Buses and Public Utility Jeeps coming from Bgy. Pala-Pala, Dasmariñas, Cavite shall load and unload passenger near the gate of Royal Turn; b) all Public Utility Buses and Public Utility Jeeps coming from Bgy. Hugo Perez, Trece Martires City/Metro South shall load and unload passengers in from of Genstar Plaza.

Section 2. - Penalty

First Offense - One Thousand Five Hundred Pesos (Php1,500)

Second Offense - Two thousand five hundred pesos (Php2,500)

Third Offense - Three Thousand Pesos and imprisonment.

Section 3. - Effectivity - This ordinance shall take effect upon its approval.
