MUNICIPAL ORDINANCE NO. 12-07

AN ORDINANCE ADOPTING IN THE MUNICIPALITY OF GENERAL TRIAS THE DISPOSITION AND ALLOCATION OF THE 80% OF PER FAMILY PAYMENT RATE (PFPR) FOR OPERATIONAL COST AND SHALL BE DIVIDED AS FOLLOWS: THE MINIMUM OF 40% FOR DRUGS AND MEDICINES (PNDF) AND THE MAXIMUM OF 40% FOR REAGENTS, MEDICAL SUPPLIES, EQUIPMENTS INFORMATION TECHNOLOGY, CAPACITY BUILDING FOR STAFF, INFRASTRUCTURE OR ANY OTHER USE RELATED, NECESSARY FOR THE DELIVERY OF REQUIRED SERVICE INCLUDING REFERRAL FEES FOR DIAGNOSTIC SERVICES IF NOT ABLE IN THE FACILITY; WHILE THE REMAINING 20% WHICH HAS BEEN ADOPTED BY VIRTUE OF MUNICIPAL ORDINANCE NO. 06-02 SHALL BE AMENDED TO BE EXCLUSIVELY UTILIZED AS HONORARIA OF THE STAFF OF THE PCB FACILITY AND FOR THE IMPROVEMENT OF THEIR CAPABILITIES AS WOULD ENABLE THEM TO PROVIDE BETTER HEALTH SERVICES AS FOLLOWS; 10% FOR THE PHYSICIAN; 5% FOR OTHER HEALTH PROFESSIONAL STAFF OF THE FACILITY; AND 5% FOR NON-HEALTH PROFESSIONALS/STAFF, INCLUDING VOLUNTEERS AND COMMUNITY MEMBERS OF HEALTH TEAMS (E.G. WOMEN'S HEALTH TEAM, COMMUNITY HEALTH TEAM); AND FURTHER AMENDING THE NAME OF THE PROGRAM PREVIOUSLY CALLED "OUTPATIENT BENEFIT PACKAGE" TO "PRIMARY CARE BENEFIT 1 PACKAGE", AND THE TERM "CAPITATION FUND" TO "PER FAMILY PAYMENT RATE (PFPR)" AS PROVIDED IN THE DEPARTMENT OF HEALTH ADMINISTRATIVE ORDER NO. 2010-0036 AND THE DEPARTMENT OF HEALTH DEPARTMENT ORDER NO. 2011-0188.

WHEREAS, on 22 August 2006, the Sangguniang Bayan approved SB Resolution No. 06-59 creating the PhilHealth Capitation Fund from the proceeds of the outpatient consultation and diagnostic benefit package to be provided by PhilHealth Insurance Corporation for qualified indigent families of General Trias;

WHEREAS, as provided in PhilHealth Primary Care Benefit 1 (PCB 1) Package Program as specified in Department of Health Administrative Order 2010-0036 and the Department of Health Department Order No. 2011-0188, the disposition and allocation of 80% of Per Family Payment Rate (PFPR) for operational cost divided as follows: the minimum of 40% for drugs and medicines (PNDF) and the maximum of 40% for reagents, medical supplies, equipments information technology, capacity building for staff, infrastructure or any other use related, necessary for the delivery of required service including referral fees for diagnostic services if not able in the facility, shall be adopted in the municipality;

WHEREAS, in further compliance to Department of Health (DOH) Administrative Order 2010-0036 and the Department of Health (DOH) Department Order No. 2011-0188, amendments to Sangguniang Bayan

Resolution No. 06-59 have to be considered such as the changing of the Program Name "Outpatient Benefit Package" to "Primary Care Benefit 1 Package"; changing the Term Capitation Fund to Per Family Payment Rate (PFPR); and applying new rules in the Disposition of the 20% of the proceeds of the PFPR (Section 2.3) as follows: 10% for the Physician, 5% for the Staff & 5% for the Non-Health Professionals, Including Volunteers;

WHEREFORE, on motion of SB Member Kerby J. Salazar duly seconded by SB Member Maurito C. Sison, SB Member Arturo P. Tacos, SB Member Lamberto M. Carampot, SB Member Christopher N. Custodio, SB Member Richard R. Parin, SB Member Mario C. Amante, SB Member Walter C. Martinez and SB Member Jayvee Arisa I. Simpan,

BE IT ORDAINED, to adopt in the Municipality of General Trias the disposition and allocation of the 80% of Per Family Payment Rate (PFPR) for Operational Cost and shall be divided as follows: the minimum of 40% for drugs and medicines (PNDF) and the maximum of 40% for reagents, medical supplies, equipments information technology, capacity building for staff, infrastructure or any other use related, necessary for the delivery of required service including referral fees for diagnostic services if not able in the facility; while the remaining 20% which has been adopted by virtue of Municipal Ordinance No. 06-02 shall be amended to be exclusively utilized as honoraria of the staff of the PCB facility and for the improvement of their capabilities as would enable them to provide better health services as follows; 10% for the Physician; 5% for other health professional staff of the facility; and 5% for non-health professionals/staff, including volunteers and community members of health teams (e.g. Women's Health Team, Community Health Team); and further amending the name of the program previously called "Outpatient Benefit Package" to "Primary Care Benefit 1 Package", and the term "Capitation Fund" to "Per Family Payment Rate (PFPR)" as provided in the Department of Health Administrative Order No. 2010-0036 and the Department of Health Department Order No. 2011-0188.


