PRESCRIBING A TWO (2)-YEAR MORATORIUM ON THE ESTABLISHMENT OF GASOLINE STATIONS WITHIN THE MUNICIPALITY OF GENERAL TRIAS.

WHEREAS, as per records show, twenty three (23) gasoline stations are presently operating in the Municipality of General Trias;

WHEREAS, as much as the right to free enterprise must be considered and respected, the uncontrolled proliferation of gasoline stations in the Municipality has caused deficit to the gas dealers and investors;

NOW, THEREFORE, BE IT ENACTED by the Sangguniang Bayan of General Trias in Session assembled, that:

Section 1. Title of Ordinance. This Ordinance shall be known as: "AN ORDINANCE PRESCRIBING A TWO (2)-YEAR MORATORIUM ON THE ESTABLISHMENT OF GASOLINE STATIONS WITHIN THE MUNICIPALITY OF GENERAL TRIAS."

Section 2. There is hereby prescribed a two (2)-year moratorium in the establishment of gasoline stations within the Municipality of General Trias.

Section 3. No permit shall be issued by the concerned offices in the Municipality in any relation to the establishment of a new gasoline station in the Municipality of General Trias within the moratorium period of two (2) years.

Section 4. Separability Clause. Any provision of ordinances, laws, decrees, and orders inconsistent with the provisions of this Ordinance are deem repealed or modified accordingly.

Section 5. Effectivity Clause. This Ordinance shall take effect fifteen (15) days upon approval, posting in conspicuous places in the Municipality or publication in a newspaper of general circulation.
