**CONDUCTING THE ANNUAL DRUG TESTING OF ALL APPOINTED BARANGAY OFFICIALS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.**

**SECTION 1. TITLE.** This Ordinance shall be known as An Ordinance Requiring All Appointed Barangay Officials in the Municipality of General Trias to Undergo Mandatory Drug Testing, otherwise known as "Appointed Barangay Officials Drug Testing Ordinance".

**SECTION 2.** The Local Government of General Trias in full adherence and support of the existing rules shall adopt, recognize and declare the following policies and programs:

- a. To promote a high standard of ethics in public service, public officials and employees shall at all times be accountable to the people and shall discharge their duties with utmost responsibility, integrity, competence, and loyalty, act with patriotism and justice, lead modest lives, and uphold public interest over personal interest.
- b. To develop the morale and dignity as well as the efficiency in public service of every Appointed Barangay Officials that they must undergo mandatory drug testing in accordance with the Dangerous Drugs Act of 2002.

**SECTION 3. SCOPE.** Mandatory drug test shall be made upon the following officials:

- a. Barangay Tanods
- b. Secretary
- c. Treasurer
- d. Lupon Tagapamayapa, and
- e. Other appointed officials

### **SECTION 4. MANNER OF IMPLEMENTATION.**

Drug test shall be conducted by an accredited Drug Testing Center of the Local Government Unit of General Trias.

Urine test shall be made randomly twice a year to the Appointed Barangay Officials upon assumption of office.

**CONDUCTING THE ANNUAL DRUG TESTING OF ALL APPOINTED BARANGAY OFFICIALS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.**

**SECTION 5. PENALTIES.** Any incumbent Appointed Barangay Officials who fail the drug test shall be removed from office.

**SECTION 6. REPEALING CLAUSE.** All other ordinances, rules and regulations which are inconsistent with the provisions of this Act are hereby repealed, amended or modified accordingly.

**SECTION 7. SEPARABILITY CLAUSE.** If for any reason, any section or provision of this Ordinance, or any portion thereof is declared invalid or unconstitutional, the remainder of this Ordinance shall not be affected by such declaration and shall remain in force and effect.

**SECTION 8. EFFECTIVITY.** This Ordinance shall take effect fifteen (15) days after its publication in a local newspaper of general circulation and after posting in three (3) conspicuous places within the municipality.
